Lewis said that they collected over 500 valid signatures which resultantly triggers a referendum. He said we would want it to be during Guild elections to save costs so we need to speak to the WAEC as soon as possible.

Nevin said that as per 5.3.2 of the Guild Regulations which says that the "Guild Council will determine all matters of detail in connection with any referendum" it would be counterproductive for the whole Council to be a part of that process. He proposed an amendment that Council directs Governance Committee to create a terms of reference for a Referendum sub-committee that would determine the process and rules of the referendum.

Lewis said he looks forward to seeing students being able to have a say on this and that UWA moves forward from this referendum.

Jacob said that there are people who have never voted in Guild elections but are interested in this topic and want to vote for NUS affiliation/disaffiliation as it is change that they can make by themselves.

- condemns the cut to penalty rates which will disproportionately impact students, locking them out of equal access to a higher education; and

condemns the 2017 Federal Budget's proposal to introduce drug testing,
 cashless welfare cards and a demerit system for welfare recipients.

Moved: Tyson McEwan; Seconded: Megan Lee

Tyson said that the campaign revolves around Centrelink and the issues that students have with it. The cuts to penalty rates makes it very difficult for students to gain an income and support themselves whilst in uni.

Megan said that the proposal demonizes welfare recipients and the drug-testing is quite cost inefficient. She said it's important that the Guild supports this campaign for the number of students who receive youth allowance and require those payments to be able to access higher education.

Ruth said she didn't understand why the Guild made motions like these as they don't seem to have any power to enact any change by passing them.

Megan said that the Guild has both a service delivery function and a representative function, so we are also there to be the collective voice of students. Additionally, by endorsing the campaign, the Guild can do things on campus to support that campaign e.g. petitions. She said that whilst it may look performative, it's important for student who are impacted negatively by the budget to see that their student representatives stand with them.

Nevin said he received an email from the NUS Welfare Officer asking for UWA's support in putting together a letter opposing the cuts to the crossbenchers in the Senate. This motion allows for Nevin to sign that letter on behalf of the Guild.

Lina added that Guild Council has a representative function. For example, if the government were to ban Muslim people from the country, Council would say that they condemn the governments anti-Islamic decision so that Muslim students at UWA know that they are supported by their representatives. The point of these kinds of motions is to fulfil the Guild's representative function.

Jacob said that more needs to be done than just a stance if Guild Council wants to address issues such as this. He said that students don't see the point in these motions being passed if they can't see the tangible action being taken.

The rest of the discussion was cut off during the recording so the following notes were taken

Zee, Tyson, Lina and Megan spoke in favour of the motion and outlined that the said proposals made it difficult for students to get welfare payments, treated students

like criminals and disproportionately impacted students with disabilities. They said

that it essentially punishes those that need help instead of providing support.

Justin spoke against the motion by explaining that some welfare recipients were

actually wasting government money and putting Australia further into deficit. He

added that the issue wasn't relevant to students and as it was federal policy, the

Guild would not be able to do anything about it.

Megan responded that the government should get their priorities right and stop

giving the multinationals tax cuts in order to fix the deficit.

Nevin added that the motion would allow him, as the President, to sign a letter to

Senate cross-benchers on behalf of UWA students.

5. That the Guild Council:

- a reaffirms its stance that Student Representative workspaces, such as the Student Representative Room and Bob Nicholson Room, should not be used for Guild election campaigning to ensure there is a divide between the operations of the Guild and Guild politics;
- b Extends this stance against Guild election campaigning to communal club spaces, such as the CCZ and Cameron Hall, so as not to impact the facilities available to clubs and their members.

Moved: Jack Looby; Seconded: Owen Myles

Jack passed the Chair to Nevin.

Jack said that the motion reflects the current policy of the Guild that student representative spaces are to remain separate from campaign spaces. He said we need to keep the operations of the Guild separate from the club spaces and acknowledge that communal club spaces need to be respected.

Owen said that this doesn't mean a candidate can't take a phone call about the election in the office etc. It just means you can't go into the space for the purpose of campaigning. Extending this to club rooms and the CCZ didn't exist when this policy was put forward initially, but it's reasonable to create a divide between Guild politics and the responsibilities of club execs.

Justin asked if any recent incidents have provoked the motion.

Jack said it was something he had been thinking about for a while, and as he wrote the CCZ policy it is something that is important to him.

Nevin moved a procedural to give Taylor speaking rights.

Taylor asked if 'club spaces' extends to club rooms or whether it was the loft and the CCZ specifically.

Jack said that the intention of the motion was just for communal club spaces.

Lewis asked if it was true that in previous years the NUS club room was used as a campaign room.

Jack said it was true and it was with the permission of the State Branch President at the time. If a particular political faction were to use a room without permission, he would find that to be a serious assault on club spaces.

Lewis asked if this motion would prevent such use.

Jack said it wouldn't- the motion only relates to communal club spaces e.g. the CCZ, Cameron Hall loft etc.

Michael asked what the tangible difference of this motion would be in terms of the rules being broken.

Jack said he would expect this to be binding such that if a political party did for example take over a room of the CCZ, Guild Council would have to take action accordingly.

Michael asked whether this includes the Bob Nicholson Room and the President's Office.

Jack said that student representative spaces are currently under this policy.

Lewis spoke in favor of the motion and said that it would stop people from using spaces such as NUS club rooms and the president's room for campaign meetings.

Jack reiterated that this motion isn't against clubs deciding whether they want to support a political party and offer them their club room, but simply against political parties using communal spaces as well as club rooms without the club's permission.

The motion was put. **PASSED UNANIMOUSLY.**

6. The 104th Guild Council condemns the rise of anti-Semitism and anti-Zionism on University campuses (including UWA), stands strongly in support of the Australian Jewish Community, and updates our policy handbook to reflect these changes.

Moved: Lewis Hutton; Seconded: Justin Workman

Lewis said he thinks it's horrible to see such actions happen on campus and this behavior is spreading to Australia from America and the UK. He said that after speaking to people from AUJS and students from the Jewish community, they have said that they want the Guild to take a stance on which side they wish to be on. He encouraged Council to vote for this motion in order to show that they are not on the side that discriminates against Jewish people and denies them of their spiritual home.

Justin echoed Lewis' comments and added that it's important to stand with Jewish students, particularly those coming from Israel, so that they feel comfortable in Western Australia.

Lina asked whether this motion reflected the same spirit of the motion passed earlier.

Lewis said that it's a similar spirit but a drastically different motion, as the one before was reactive to what had happened whereas this one was both reactive and proactive in creating a safe space for Jewish student from Israel.

Nevin proposed an amendment to split the motion into two parts, as he believed most people would support the 'anti-Semitism' part of the motion but there would be more discussion surrounding the 'anti-Zionism' part.

Michael M said that by dividing the motions it loses the point of them. He said he didn't see the rationale of doing so as it weakens the message behind the motion, which was worded to have specific effects by the elected representatives, and that doing so was silly politics.

Lina said that she didn't think it was Michael's place to say that it's not okay to divide the motions, as it is in the standing orders that democratically elected

representatives are able to amend motions as they see fit. She said she didn't think it's silly politics to divide it into one motion that all or most of Council would be in favor of, and another motion that is much more controversial. Anti-Semitism and Anti-Zionism are completely different issues that shouldn't be voted up together or voted down together.

Lewis said it was hypocritical to do this as there was previous discussion on the first part of this motion being the same as the previous motion. He said the motion had been made in consultation with students from AUJS and the wider Jewish community on campus, and that it's important to take a stance in support of the religious freedoms of students from Israel.

Nevin said that he wanted to have the choice to vote for the part of the motion that he agreed with and not vote for the part that he didn't agree with. He said that Michael saying he should just vote down the motion all together is a political move in itself as there as been a history of 'Save Campus Culture UWA' posting motions without context saying that members of Guild Council didn't agree with the whole motion when in reality they just didn't agree with parts of it.

The amendment was put. Carried.

Motion was amended as follows:

 The 104th Guild Council condemns the rise of anti-Semitism on University campuses (including UWA), stands strongly in support of the Australian Jewish Community, and updates our policy handbook to reflect these changes.

Lewis said that it's good to take a stance, update the policy handbook and create a safe space for Jewish students.

The motion was put. PASSED UNANIMOUSLY.

2) That the 104th Guild Council condemns the rise of anti-Zionism on University campuses (including UWA), stands strongly in support of the Australian Jewish Community, and updates our policy handbook to reflect these changes.

Lewis said that he has had students from the Jewish community approach him on campus and saying that they don't only feel unsafe because of discrimination based on their religion, but they're also not feeling safe in the way that people are telling them that the country they come from is inferior and doesn't have a right to exist.

He said that Guild Council should accept that these students have the right to be proud to be from a country that has the right to exist after a genocide of six million people and create a safe space for them. By passing this motion, we would be one of the first universities in Australia to take this stance and we would see an influx of students by creating a safe space for them.

Justin echoed Lewis' comments and said that Israel is a place where people are welcome regardless of their background, which is in stark contrast to other areas, so it's a shame that people are misled to believe that Israel is not a place of happiness.

Owen asked Lewis what he defined 'anti-Zionism' as for the purposes of the motion, as there are a number of different definitions that exist.

Lewis said he used the Oxford dictionary definition.

Owen read the Oxford dictionary definition for 'Zionism' which states that it is "a movement for (originally) the re-establishment and (now) the development and protection of a Jewish nation in what is now Israel. It was established as a political organization in 1897 under Theodor Herzl, and was later led by Chaim Weizmann".

Lewis clarified that anti-Zionism is the idea that the state of Israel doesn't have the right to exist.

Justin reiterated that its profoundly disgusting the distaste people have for Israel- an area set up as a place of refuge for people after the atrocities of the Holocaust. He said that Palestine is incredibly racist towards Israel and is literally set up to not let Jews in as a country that denies Jewish entry and hates Jewish people.



Jack said he understands that there are very deep political views on this issue and it's important to be respectful to both sides of the spectrum. He said it'd be good for the speaker to avoid inflammatory speech whilst making their point.

Justin said that it's important that the Guild takes a stance in support of students from Israel and we cannot discriminate in these issues regarding who we stand in support of.

Lina said that her being against this motion is not her being against students from Israel, but rather her against Council being in support of the State of Israel itself, which is two very different things. She said that Justin made it seem as though the people from Palestine were kicking the people from Israel out, but in fact Palestine was an established State until it was colonised by what is now the State of Israel, and we are now erasing the experience of the Palestinian people just like we did when calling Australia, a British colony when it was Aboriginal land. She added that she didn't think they could say Centrelink isn't relevant to students but then say that anti-Zionism is relevant to students. She said she personally has had family who went to Palestine to provide medical aid and got shot dead by Israeli soldiers, so it is something very close to her heart. She added that she knows a very well-spoken Israeli person who's grandparents died in the Holocaust but he completely opposes the State of Israel because what Israel is doing to the Palestinians now is exactly what happened to the Jews in the Holocaust. She said that this isn't something that we should be taking any political stance on, especially this particular one.

Jack passed the Chair to Nevin.

Michael said that this is a proactive motion in protecting the Jewish students of UWA and whilst it may look like a battle of ideological stances, we are actually making a proactive policy to let students know that we support them. By being one of the first

Australian universities to take this stance, it welcomes incoming students to the UWA community. He said that the issue is an important one to many students and at the end of the day we can come to a conclusion with rational, logical understanding of one another.

Jack spoke against the motion. He said anti-Semitism is something that shouldn't be tolerated on campus because discrimination against people of different backgrounds is never okay and the Guild needs to support that. On the other hand, anti-Zionism is a political issue. They are two very different issues and should be treated separately.

He said that supporting anti-Zionism does not mean that you are condemning the Jewish people or religion, but rather the political actions by that particular community. He also acknowledged the power imbalance involved- the Israeli people are some of the wealthiest and most technologically advanced in the world whereas people in the Gaza strip are getting killed and living in slums. He said that when Zionism has perpetuated human war crimes as set by the UN it self, it's not trite of the Council to split the motion and debate the two issues separately.

Lewis said that to compare what is happening to the Palestinians to the Holocaust is a falsification of facts. He said that anti-Zionism is the belief that Israel shouldn't exist, when the state was created by the UN after the Holocaust so that the Jews could have a safe place to live. He said that students really care about the issue and Council should condemn the rise of anti-Zionism on campus just as we should condemn the rise of any other extreme movements like it.

Zee said that you can't say that the atrocities that are happening in Palestine are any less than those that happened in the Holocaust, as they are different types of atrocities within different political scenes and you cannot compare them. She asked Lewis how he can compare two different lives.

Lewis said he would rather see no one be killed and he is not saying that we shouldn't stand in support of Palestinian students on campus. He said he thinks the Holocaust was different to this scenario, as the Holocaust involved Jews being taken into concentration camps and killed, whereas the Israel Palestine issue is a war where terrorists are attacking the Jewish state and the Jewish state is responding. He said it's not very relevant to bring up that comparison, and the most relevant point is that Jewish students on campus are feeling unsafe. He added that the website on the posters said that "the Holocaust was fake because the Israelis wanted to take over the holy land" and AUJS asked him to respond to that, which he is doing by condemning anti-Zionism.

The motion was put. **FAILED.**
